INTERMEDIATE SWITCHING:

Except as otherwise provided, GDLK will assess an intermediate switching charge against the carrier delivering to GDLK; applicable to either loaded or empty cars.

Note 1: Non Hazardous	\$300/car
Note 2: Hazardous material other than TIH/PIH	\$500/car
Note 3: TIH/PIH	\$960/car

INTERMEDIATE SWITCHING AT KALAMAZOO:

GDLK will perform intermediate switching between CN and NS at Kalamazoo, MI. NS will pay charges in either direction. NS will absorb carhire liability for cars handled by GDLK.

SPECIAL RECIPROCAL OR INTERMEDIATE SWITCHING:

When an intermediate switching movement cannot be handled in regular train service, additional charges for the special handling will be assessed in addition to any other charges applicable to the movement. Additional charges are as follows:

A. For the first five (5) cars in the same movement	\$1279/per movement
B. For each additional car in excess of five (5) cars in the same movement	\$147/car
